### **Executive summary**

In 2020, with comprehensively strengthened pesticide management, China's pesticide industry continued the shift from high-speed development to environmental friendly and high-quality development. Despite huge blow of the COVID-19 outbreak in Q1 2020, the pesticide industry still quickly overcame difficulties and maintained a steady and sound development. The transformation and upgrading has achieved remarkable results in the industry, the process of merger and reorganization has been accelerated, and the industrial concentration has been significantly improved. Pesticide enterprises have made new progress in scientific and technological innovation, and continuously launched new varieties independently developed. The competitiveness of China's pesticide products has been continuously enhanced, and the export proportion of technical and formulation has been improved.

List of 2021 China Top 100 pesticide enterprises, 2021 China Top 100 pesticide formulation enterprises and popular pesticide brands (by sales) in China in 2020, selected by the CCPIA, were disclosed in the 8th Analysis Meeting of Economic Operation in Pesticide Industry on 13 May, 2021. In general, both total revenue and the entry threshold of top 100 pesticide enterprises in 2020 have increased over 2019. Moreover, the sales of the top 10 accounted for about 40% of the total, which means industry concentration increased significantly. Compared with the technical enterprises, the scale of formulation enterprises was small on average, but their development was good overall. In the list of popular pesticide brands, the pesticide varieties with high efficiency, low toxicity and low residue increased, and the proportion of environmentally friendly formulation products rose.

With intensifying competition and rigorous enforcement of environmental protection measures, China's pesticide industry has entered a new round of integration, which also puts forward higher requirements on domestic pesticide enterprises. These enterprises have been trying to improve themselves to adapt to the new environment, as they are aware that only by continuously improving product quality, services and creativity, and by enhancing scientific and technological strength can they maintain advantages in pesticide industry.

The USD/CNY exchange rate in this newsletter is USD1.00=RMB6.4660 on 1 Aug. 2021 sourced from the People's Bank of China.

### Methodology

The report is drafted by diverse methods as follows:

- Desk research

The sources of desk research are various, including published magazines, journals, government statistics, industrial statistics, customs statistics, association seminars as well as information from the Internet. A lot of work has gone into the compilation and analysis of the obtained information. When necessary, checks have been made with Chinese agrochemical players.

#### - Internet

CCM contacted with players in the domestic agrochemical industry through B2B websites and software as well as obtained registration information on the internet.

- Data processing and presentation

The data collected and compiled are sourced from:

### 1 Review of China's pesticide industry in 2020

### 1.1 General situation

In 2020, the outbreak of COVID-19 caused a huge impact on global economic development. Facing various risks and complex international environment, pesticide industry actively overcame difficulties by enhancing innovation ability, speeding up market expansion, and seeking new markets to expand exports.

In 2020, the output of pesticides in China decreased first but later increased. The pesticide industry attained stead growth of economic benefits with significantly increasing output value and profit. As domestic epidemic situation was controlled, pesticide production proceeded in an orderly manner and the output increased steadily, ensuring effective supply to satisfy domestic agricultural demand. In terms of export, thanks to favorable policies rolled out by the government, flow of pesticide export was smooth; the annual export volume & value reached a new high in recent three years.

In general, main economic indicators of the pesticide industry still maintained growth, even though some enterprises failed to operate normally due to the aftermath of COVID-19.

With the supply-side structural reform and enterprises' transformation and upgrading, concentration ratio of China's pesticide industry continued to increase. In 2020, there were 693 enterprises above designated size involved in pesticide business in China, 26 less than the number in 2019 and 293 less than 986 in 2010. Although the number decreased, the total assets and revenues from main business have increased steadily, and the economic benefits they generated were remarkable. According to data from the National Bureau of Statistics, in 2020, the assets of the 693 pesticide enterprises totaled USD43.55 billion (RMB281.57 billion), with a year-on-year increase of 5.90%; the main business revenue together reached USD35.27 billion (RMB19.06 billion), a year-on-year increase of 6.10%; the total profit was USD2.95 billion (RMB19.06 billion), up by 0.50% year on year; the total profit of chemical pesticide technical increased by 1.80% year on year, while that of biochemical and microbial pesticides decreased by 5.5% over 2019.

It is worth noting that due to the increased cost of raw materials under the influence of the global epidemic and China's rigorous enforcement of environmental protection measures, production cost in pesticide enterprises went up. Although product price increased accordingly, profit margins were still squeezed, which slowed down the growth of total profit of these enterprises above designated size.

Since 2015, with the implementation of the policy "achieving zero growth in the use of chemical fertilizers and pesticides by 2020", as well as the phasing out of highly toxic organophosphorus pesticides (insecticides in majority), the total output of pesticides has decreased steadily. Data from the National Bureau of Statistics show that in 2020, the output of chemical pesticide technical (converted into 100% AI, hereinafter) of enterprises above designated size in the pesticide industry was 2.15 million tonnes, with a year-on-year decrease of 1.06%. Thereinto, the output of herbicide, insecticide and fungicide was 46.74%, 14.06% and 5.35% of the total respectively.

As to pesticide production in different provinces, the top three in pesticide technical output in 2020 are Jiangsu Province, Shandong Province and Sichuan Province, the trio accounting for 53.21% of the domestic total, according to the data from the National Bureau of Statistics.

Jiangsu Province, as the largest pesticide producer in China, saw its pesticide technical output decrease by 4.9% year on year, as relocation, shutdown & rectification in chemical enterprises have accelerated, which is prompted by environmental protection, work safety improvement and industrial structure adjustment in chemical parks. While Shandong Province and Anhui Province had their pesticide technical output rose by 26.50% and 65.20% year on year respectively, driven by continuous and effective release of production capacity and increasing demand for some products. Besides, Hunan Province, Gansu Province and Ningxia Hui Autonomous Region also experience fast growth in pesticide technical output, mainly due to effective release of new production capacity. In contrast, owing to the shutdown caused by floods in Q3 2020, Sichuan Province witnessed a 26.50% slump in its pesticide technical output. Hubei Province, Hebei Province, Guangxi Zhuang Autonomous Region and Guangdong Province also experienced output drops, down by 15.10%, 13.90%, 22.20% and 45.10% respectively.

In 2020, the price of pesticide technical in China was relatively low, with small fluctuations. Since 2019, affected by multiple factors such as adverse weather conditions in some regions and the Sino-US trade war, the global pesticide price had continued declining. Based on this situation, the China Agrochemical Price Index (CAPI) decreased on the whole.

In Q1 2020, production in domestic pesticide enterprises were restricted due to COVID-19 pandemic. Disruption to the supply chain, especially the supply of raw materials greatly impacted normal operation of pesticide industry. In Q3, domestic market operated stably, but overseas pandemic situation was severe, which caused most of the overseas trade to be transformed into domestic sales. China's domestic market competition intensified and the price of pesticide technical decreased. In Q4, the tight supply of raw materials led to rising cost price, and thus the pesticide price showed an upward trend.

- ✓ In Q1, limited operation of pesticides, disrupted logistics and insufficient supply led to a price rise. Pesticide price index rose slightly in Feb. But in March, production resumption process accelerated and logistics gradually recovered, so the price index decreased slightly.
- ✓ In Q2, with increasing overseas demand for pesticides, export volume went up significantly in the short term. In April, the pesticide technical price index increased to 90.27, the highest in 2020.
- ✓ In Q3, due to the direct impact of epidemic situation overseas, the price index decreased to 84.65 in Sept., the lowest in 2020, down 6.23% from April.
- ✓ In Q4, the supply of pesticide raw materials was tight, and the price index rose. In Dec., the price index rebounded to 86.84.

Specifically:

- ✓ Herbicide technical price index kept stable in H1; it increased steadily in H2, from 66.94 in July to 74.62 in Dec., with an increase of 11.47%.
- ✓ Insecticide technical price index declined on the whole, from 116.56 in Jan. to 99.11 in Nov. It rebounded above 100 in Dec.
- ✓ Fungicide technical price index peaked at 142.72 in April. Since April, it declined continuously, reaching at 114.08 in Dec., down 20.07% from the peak.

#### **1.2 Imports and exports**

In 2020, the global epidemic situation was severe, but the situation in China was effectively controlled. Since Q2, domestic enterprises resumed production in an orderly manner, which helped alleviate negative influences brought up by adverse factors such as the global economic environment deterioration in early 2020, and provide an opportunity for expanding China's pesticide import and export—trade rebounded sharply. Statistics from the National Bureau of Statistics show that the total import and export trade value of pesticides in China in 2020 was USD8.54 billion, up by 51.80% year on year. The trade surplus reached USD6.71 billion, with a yearly increase of 63.80%. The total import & export value and trade surplus of herbicides, insecticides and fungicides also increased in varying degrees.

As operating rates of overseas pesticide enterprises were damaged by COVID-19, strong demand for China's pesticides was witnessed, and the export volume & value went up significantly in 2020. According to the data from the National Bureau of Statistics, China exported 2.51 million tonnes of pesticides, with a yearly increase of 71.20%; the export value was USD7.62 billion, up by 56.90%.

In 2020, China's overall import volume & value of pesticides maintained a stable growth, with a year-on-year increase of 22.60% and 19.60% respectively. Insecticides, in particular, saw large year-on-year increase in import value. However, both herbicides and fungicides had decreases in import volume & value.

### 2 Top pesticide enterprises in China

#### 2.1 2021 China Top 100 pesticide enterprises

In 2020, the pesticide industry was in an unfavorable situation, facing disadvantages such as the COVID-19 pandemic and ensuing trade risks, agricultural production reduction by bad weather, and disruptions to the pesticide supply chain. At the same time, with implementation of new regulations and policies concerning pesticide management, pesticide industry has entered a high-quality development stage. Pesticide enterprises paid more attention to environmental protection and work safety, energy consumption reduction and product innovation. Small enterprises withdrew from the market, and the industry concentration increased significantly. For example, Jiangsu Province have stepped up industrial regulation, and pesticide production capacity has been gradually transferred to the central and western China. China's pesticide utilization rate improved continuously. It was obvious that high-efficient and low-toxic pesticides got on the fast lane of development.

Though faced with the severe market situation, 72 companies achieved an increase in sales revenue over 2019 and most of these enterprises had significant growth in sales. Statistics show that the total sales of the top 100 enterprises on the list reached USD32.25 billion (RMB208.53 billion), with a yearly increase of 13.57% (the figure of the previous year was 6.87%). In 2021, the entry threshold of top 100 enterprises rose to USD70 million (RMB451 million), up 13.03% from the previous USD57 million (RMB399 million).

Among the listed companies, the top ADAMA Ltd. had sales of more than USD3.87 billion (RMB25 billion). Following its lead, other 5 enterprises had sales over USD770 million (RMB5 billion), two more than last year. 58 enterprises achieved sales within the range of USD155 million to USD770 million (RMB1 billion–RMB5 billion).

The top 10 enterprises raked in USD12.27 billion (RMB79.34 billion) in pesticide business, up by 12.95% over the previous year, accounting for 38.05% of the total sales on the list. This shows that the market concentration of China's pesticide industry is relatively high, and the leading enterprises have played a significant role.

Specifically, the top three in 2021 remained the same compared with 2020. ADAMA Ltd. is far ahead of its competitors. Jiangsu Yangnong Chemical Co., Ltd. ranked the second with revenue of USD1.51 billion (RMB9.75 billion), a year-on-year increase of 12.91%. The No.3 went to Shandong Weifang Rainbow Chemical Co., Ltd., with sales of USD1.12 billion (RMB7.24 billion) in 2020. It is worth mentioning that Sino-Agri Leading Biosciences Co., Ltd. had revenue of USD1.02 billion (RMB6.61 billion), with a yearly increase of 491.85%, soaring to No. 4 from No. 55 in 2019. This is mainly due to the company's efforts to stabilise production and to increase pesticide sale volume greatly.

Compared with last year's list of the Top 100 pesticide enterprises, here come 8 new entrants this year. In terms of annual growth in revenue, 9 enterprises had over 50% increase in 2020, one more than the previous year. In addition, 19 companies showed negative year-on-year growth, 9 less than last year.

In addition, according to incomplete statistics, more than 20 enterprises above designated size optimized their layout and improved their industrial chain through reorganization, merger and acquisition and joint establishment of subsidiaries in 2020.

- Red Sun International Industrial Co., Ltd., a wholly-owned subsidiary of Nanjing Red Sun Co., Ltd. had 25% equity of Shanghai Guoxi Financial Management Co., Ltd. transferred from Zhouji Industry Group Co., Ltd.
- ✓ ADAMA Ltd. acquired a 51% equity stake in Shanghai Dibai Plant Protection Co., Ltd. and a 51% equity stake in Jiangsu Kelinong Agrochemical Co., Ltd. from Jiangsu Huifeng Bio Agriculture Co., Ltd.



### 2.2 Geographical distribution of 2021 China Top 100 pesticide enterprises

Analysis of the geographical distribution of 2021 China Top 100 pesticide enterprises shows that the top three provinces in pesticide revenue in 2020 are Jiangsu Province, Hubei Province and Shandong Province. The pesticide revenue of the three provinces accounts for 56.79% of the total.


In 2020, the total pesticide revenue in Jiangsu Province was USD8.96 billion (RMB57.91 billion), accounting for 27.77% of the total. Jiangsu Province has 29 enterprises in the list, down by 3 from that in 2019. Hubei Province, with just 3 enterprises in the list, raked in pesticide revenue of USD4.74 billion (RMB30.67 billion), and ranks the second, mainly due to the excellent performance of ADAMA Ltd. Shandong Province ranked the third in revenue, with 16 enterprises on the list and pesticide revenue of USD4.62 billion (RMB29.85 billion).

### **3** Top pesticide formulation enterprises in China

### 3.1 2021 China Top 100 pesticide formulation enterprises

In 2020, pesticide industry entered a high-quality development stage, and the effect of industry transformation and upgrading was prominent. Enterprises in the 2021 Top 100 List for pesticide formulation business achieved total revenue of USD6.00 billion (RMB38.81 billion), with a yearly increase of 12.65%. Sales threshold for the Top 100 list this year was USD15 million (RMB100 million).

Sales of the top 10 companies altogether approached USD2.25 billion (RMB14.51 billion), accounting for 37.39% of the total, with an increase of 14.69% over the previous year. It is worth noting that 8 companies achieved sales of more than USD155 million (RMB1 billion), one more than the 2020. There are 13 enterprises with sales between RMB500 million and RMB1,000 million (approximately within the range of USD77 million–USD155 million), and the rest 79 enterprises with sales between RMB100 million and RMB500 million (within the range of USD15 million to USD77 million). On the whole, compared with the technical manufacturers, the average scale of enterprises in formulation business is still small, but the overall sales performance has increased significantly.

Specifically, Shenzhen Noposion Agrochemicals Co., Ltd. (Shenzhen Noposion) ranked first, with sales of USD431 million (RMB2,784 million) in 2020. Guangdong Zhongxun Agri-science Corporation came second, the same as 2020, and it achieved sales of USD334 million (RMB2,161 million). The third place belonged to Jiangxi Zhengbang Crop Protection Co., Ltd., up 2 places from 2020.

This year, 19 new comers made it to the list, among which Sichuan Guoguang Agrochemical Co., Ltd. ranked 13th, and Shandong Vicome Greenland Chemical Co., Ltd. ranked 20th.

In terms of annual growth rate in pesticide revenue, 6 recorded 50% over year-on-year increase, especially Sunong (Guangde) Biotechnology Co., Ltd. (94.29%), Zhejiang Jishun Plant Technology Co., Ltd. (71.84%) and Anhui Shengdan Biochemical Co., Ltd. (62.00%).





### 3.2 Geographical distribution of 2021 China Top 100 pesticide formulation enterprises

Through the analysis of the geographical distribution of 2021 China Top 100 pesticide formulation enterprises, it is known to us that the sales of Jiangsu Province was USD1.09 billion (RMB7.07 billion), 18.23% of the total, ranking the first. Jiangsu Province has 16 companies entering the list of Top 100 pesticide formulation enterprises, 2 more over last list. Although Shandong Province had 19 companies into the list, their combined revenue reached USD0.95 billion (RMB6.15 billion), 15.84% of the total, ranking the second. Guangdong Province ranked the third, with only 7 companies on the list and the revenue of USD0.93 billion (RMB6.03 billion). It's worth noting that the companies ranking first and second in the list are both from Guangdong Province.




Figure 3.2-2 Share of pesticide revenue of 2021 China Top 100 pesticide formulation enterprises by region, 2020

### 4 Top crop protection brands in China in 2020

Popular pesticide brands (by sales) in China in 2020, selected by the CCPIA, were disclosed in the 8th Analysis Meeting of Economic Operation in Pesticide Industry on 13 May, 2021.

The lists of 2020 popular pesticide brands in China this year include 77 products from 72 enterprises. The listed brands cover 13 herbicide products, 14 insecticide products, 17 fungicide products, 8 plant growth regulator products, 11 biopesticide products and 14 blockbuster possible products. Since 2015, the CCPIA has selected and awarded China crop protection popular pesticide brands based on multiple factors such as market sales, brand value, market share and product performance. These lists could not only reflect the market demand and development potential of the pesticide products, but also play an important role in measuring the strength of domestic products and predicting the domestic market.

Along with intensified competition within the industry and rigorous enforcement of environmental protection measures, China's pesticide industry has entered a new round of integration, which also puts forward higher requirements on pesticide enterprises. Pesticide enterprises have been trying to improve themselves to adapt to the ever changing environment. Only by continuously improving product quality, services and creativity and enhancing scientific and technological ability can these enterprises maintain advantages in pesticide industry.
