- Telephone interviews with domestic producers, joint ventures, service suppliers and governments
- Third-party data providers
- Comments from industrial experts
- Professional databases from other sources
- Information from the internet

1 Registration of clethodim in China

Generally, clethodim formulations are applied to fields of soybean, rapeseed, tobacco, potato, mung bean and red bean against gramineous weeds.

As for the types of clethodim formulations, only three (EC, OD and ME) have been registered. Among the registrations of clethodim's single formulations in China, XXX were for EC and only XXX for OD. In terms of mixed formulations, XXX registrations were for OD, XXX for EC and XXX for ME.




Figure 2.1-1 Capacity and output of 90% clethodim technical in China, 2019–H1 2023
